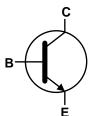

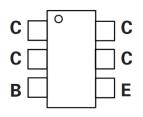

Top View Pin-Out

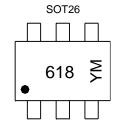

**Transient Thermal Impedance** 



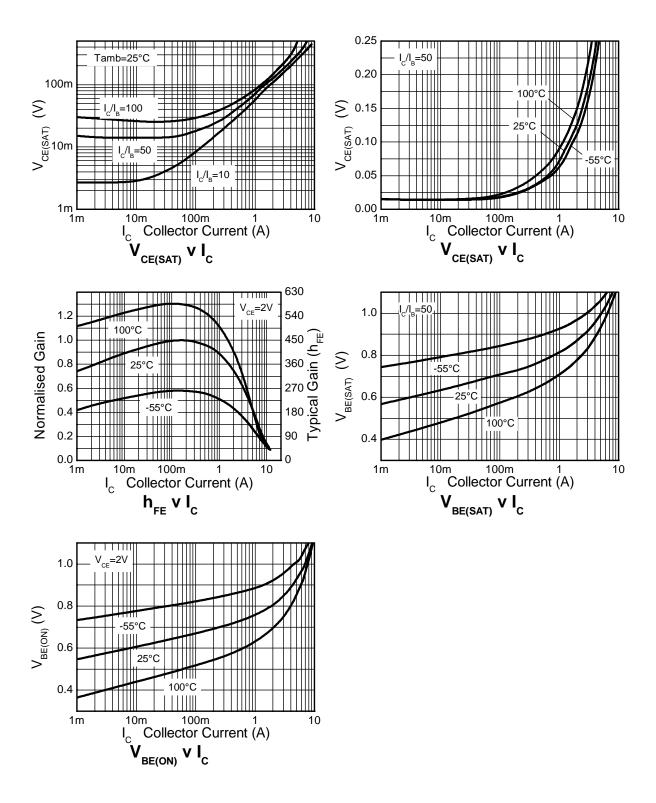

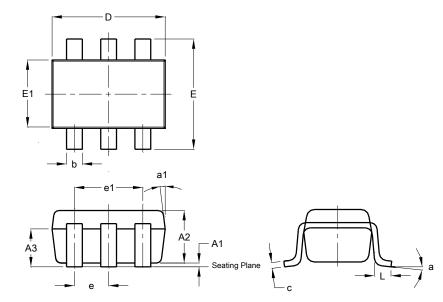

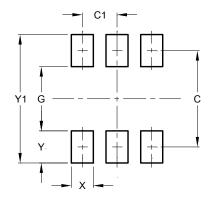
