






LED is recommended for reflow soldering and soldering profile is shown below.

Reflow Soldering Profile for SMD Products (Pb-Free Components)




- 1. Maximum soldering temperature should not exceed 260°C

- Do not put stress to the epoxy resin during high temperatures conditions






♦ Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)




Mask open area ratio:80% Mask thickness:80~100um




Remarks:


- 1. Wavelength: +/-1nm

- 3. Forward Voltage: +/-0.1V


