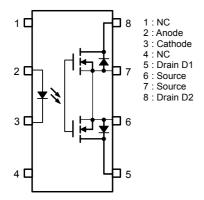

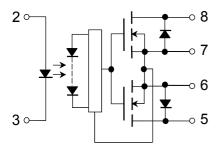

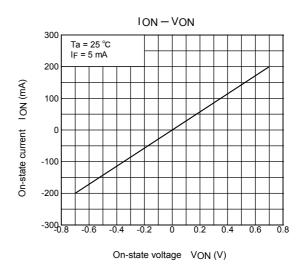


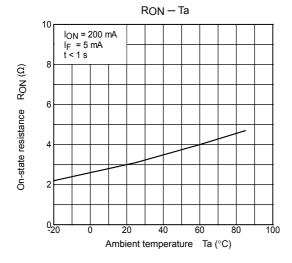


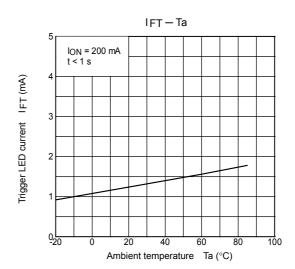


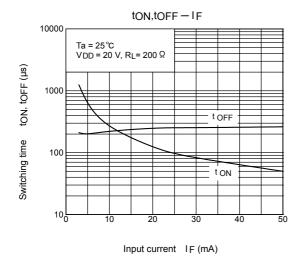


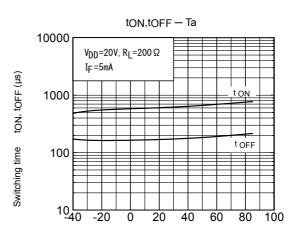




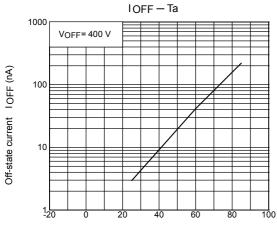








Ambient temperature Ta (°C)
